Al liderazgo de la Coalición de Acción sobre violencia basada en el género del Foro Generación Igualdad:

A 25 años de la adopción de la Plataforma de Acción de Beijing, el Foro Generación Igualdad constituye una oportunidad fundamental para reafirmar el carácter prioritario de la igualdad sustantiva en todo el mundo y para acelerar la puesta en marcha de acciones concretas para poner fin a la violencia basada en el género (VBG). Reconocemos el importante papel que ustedes han desempeñado para impulsar acciones que abordan prácticas nocivas como los matrimonios y las uniones infantiles, tempranas y forzadas (MUITF) y la mutilación/ablación genital femenina (M/AGF) a través de compromisos, recursos y voluntad política. Compartimos la creencia de que abordar los MUITF y la M/AGF sigue siendo una agenda pendiente para lograr la igualdad de género.

Cada año, 4.1 millones de niñas y adolescentes son sometidas a la M/AGF¹ y 12 millones de niñas y adolescentes se unen antes de cumplir los 18 años.² En ciertos contextos, estas prácticas están interrelacionadas y la M/AGF es precursora de los MUITF. Ambas prácticas violan los derechos de las niñas, adolescentes, jóvenes y mujeres y les niegan la capacidad de acceder a todos sus derechos y cumplir sus aspiraciones. En el ámbito internacional ambas se reconocen como tipos de violencia basada en el género con consecuencias económicas, sociales y físicas permanentes que afectan no sólo a las niñas y adolescentes, sino también a sus familias, sus comunidades y sus países.

La igualdad de género no puede conseguirse mientras estas prácticas nocivas continúen existiendo. Es por esto que nosotras, las 625 organizaciones de la sociedad civil y las 75 personas de 79 países que firmamos esta carta le instamos a que haga que poner fin a los MUITF y la mutilación genital femenina sea una prioridad de la Coalición para la Acción contra la violencia de género, incluyendo:

- Invertir en programas e investigaciones basados en evidencia, con la participación de organizaciones de base comunitaria y con perspectiva de género en todos los ámbitos donde ocurren los MUITF y la M/AGF.
- Apoyar los marcos legales y de política pública para que sean integrales y multisectoriales y pongan a las niñas y adolescentes al centro para abordar los MUITF y la M/AGF, incluyendo a los contextos de crisis humanitaria y en situación de marginación.

- Hacer referencia explícita a las prácticas nocivas, incluidos los MUITF y la M/AGF, como formas de violencia basadas en el género, y garantizar que se integre su abordaje en todos los programas de respuesta y recuperación ante situaciones de crisis.
- Incluir en el plan de trabajo de la Coalición de Acción indicadores de rendición de cuentas sobre el progreso en materia de MUITF y M/AGF para medir el impacto.
- Promover la participación significativa de las niñas, adolescentes, jóvenes y mujeres en las consultas y el diseño de las Coaliciones de Acción, a fin de garantizar que las voces de las más afectadas por prácticas nocivas tengan peso en las soluciones.

Como aliadas de la Plataforma Global de Acción orientada a terminar con la M/AGF³ y como membresía de *Girls Not Brides*: la Alianza Global para Terminar con el Matrimonio Infantil, representamos a organizaciones de todas las regiones con el objetivo común de que las niñas y adolescentes vivan libres de todas las formas de discriminación y violencia.

A 10 años de cumplir con los objetivos de la Agenda 2030, el Foro Generación Igualdad es una oportunidad muy valiosa para hacer un balance de los avances logrados para erradicar las prácticas nocivas y dar un nuevo impulso a la acción acelerada en relación con el Objetivo de Desarrollo Sostenible (ODS) 5.3.⁴ El ritmo para terminar con el matrimonio infantil para 2030 debe ser 12 veces más acelerado en comparación con los esfuerzos actuales; y 13 veces más rápido para terminar con la M/AGF. Además, el impacto de la Covid-19 ha hecho todavía más importante que nos esforcemos para evitar que se produzcan dos millones de casos adicionales de M/AGF y 13 millones más de MUITF. Si no se abordan los MUITF y la M/AGF no sólo no lograremos la igualdad sustantiva de género para el 2030, sino que tampoco alcanzaremos los objetivos de desarrollo sustentable relacionados con la pobreza, la salud y la educación, entre otros.⁵

Al abordar los MUITF y la M/AGF de manera conjunta, podemos trabajar hacia el objetivo común de lograr la igualdad sustantiva de género en un mundo en el que las mujeres, jóvenes, adolescentes y niñas vivan libres de discriminación y violencia y así logren alcanzar su pleno potencial.
